Message from the President Dr. David Melancon



After the May board meeting, the Yellow Page Review Committee started the process of reviewing dental advertisements in all of the telephone directories published in Louisiana. This was a massive undertaking and one that has been very time consuming. The board rules including those on advertising are designed to protect the public. An advertisement should only be released for publication after a review of the board rules to ensure compliance. In assessing your advertisement, you should always keep in mind that most of the people who are viewing your advertisements are not sophisticated users. The majority of violations that

were found by the committee were simple things like failing to include the words "general" or "family dentistry" or advertising "cosmetic" and "sedation dentistry" in the same font size as "general" and "family dentistry." While some practitioners have argued that these are technical violations, the public could be misled by the failure to identify the practitioner as a general dentist especially with all of the services that are normally included in the advertisements. Finally, group practices must ensure that they are properly identified in accordance with LAC 46:XXXIII.301. Also, all individuals that are listed and benefit from the advertisement assume total responsibility for the placement and content of the advertisement. So if you are working in a practice that advertises make sure you review the advertisement before it is placed to ensure compliance with the rules. Failure to do so could have negative consequences.

The board is once again facing criticism over a proposed rule. In July, the board published a notice of intent to promulgate LAC 46:XXXIII.130, "Automated External Defibrillator." The proposed rule, which has taken two years to make it to this point, provides that each dental office must be equipped with an AED by January 1, 2013. The rule will become effective on October 20, 2012 assuming no legislative oversight hearings are conducted. This rule sets forth the board's position that any dentist who is practicing without an AED in his or her office is failing to satisfy the prevailing standard of care. Louisiana is not the first state to mandate the placement of AEDs. Florida's rule on the placement of AEDs has been in effect since 2006. Joining Florida are the states of New York, Illinois, Mississippi, and Massachusetts. While the action of the named states was persuasive to the board, the ultimate decision to move forward with the rule was based on other factors, namely, the pronouncement by the legislature in 1999 and the training and requirements of American Heart Association in the BLS and ACLS courses.

In 1999, the legislature addressed the need for AEDs. After conducting hearings on the subject, the legislature found that each year more than three hundred fifty thousand Americans die from out-of-hospital sudden cardiac arrest. More than ninety-five percent of these Americans die because a lifesaving defibrillator did not arrive at the scene of the emergency in time. In addition, the American Heart Association estimates that more than twenty thousand deaths may be prevented each year if defibrillators were more widely available to designated responders. Based upon these findings, the legislature felt compelled to encourage the acquisition, deployment and use of AEDs throughout the state in an effort to reduce out-of-hospital deaths due to sudden cardiac arrest. AEDs are now found in schools, health clubs, and shopping malls just to name a few.

In order to renew our licenses to practice, we must be currently certified in Cardiopulmonary Resuscitation Course "C" Basic Life Support for Health Care Providers as defined by the American Heart Association, the Red Cross Professional Rescue Course or an equivalent. Each and every one of us is required to understand and use AEDs in order to complete the Basic Life Support for Healthcare Providers and Advanced Cardiac Life Support courses. Depending on the number of rescuers responding to a sudden cardiac arrest, defibrillation is either step two or three in the algorithm. To make early defibrillation possible, a defibrillator must be immediately available to emergency personnel responding to a cardiac arrest.

The final issue addressed by the board was the cost of compliance. The board is not unsympathetic to the cost of regulatory compliance or the current economy. However, I think we can all agree that saving one life because we have an AED available is worth the cost of compliance with the proposed rule. The members of the board voted unanimously to pass the proposed rule.

In closing, I would like to thank my fellow members of the board, the board staff, and the LDA, its board members and director for all that they have done during my tenure as President. Without the cooperation of all of these individuals, it would be impossible to fulfill the mission of the board.

From the Desk of the Executive Director

The board started statewide CDC and anesthesia inspections in August 2011 and the process has been smooth. However, in performing the inspections the following issues have arisen. Dentists and hygienists are not posting their license and renewal certificates in plain view in accordance with LAC 46:XXXIII.104. In addition, some practices that are administering anesthesia are doing so without the necessary permits. Please remember that LSA-R.S. 37:793 requires that you have not only a personal permit but also an office permit for the office in which you administer the anesthesia. The office permit must be for the highest level of anesthesia that is administered in the practice. In the event that the practice changes locations or additional practice locations are added, new office permits must be obtained.

In addition to the issues above, the inspector has identified issues with some controlled substances inventories. The board has two rules that set forth the required inventories that must be maintained and they may be found in the Dental Practice Act at LSA-R.S. 37:794 and LAC 46:XXXIII.320. These rules require a licensee to maintain an inventory of all controlled substances in his or her possession or under his or her control. In addition to the referenced rules, Title 21 CFR 1304.11 sets forth the required inventories that must be maintained by a practitioner to comply with federal law. The cited rules provide that a licensee must prepare a complete

and accurate inventory of the substances in Schedules I-V. Further, practitioners with multiple practice locations should register each location as provided in Section 1304.11. Finally, the cited rule requires a separate inventory for each registered location and each independent activity registered. The cited rules are clear, concise and easy to follow. Failure to comply with the cited rules can lead to disciplinary action by the board and criminal action by the Drug Enforcement Administration.

Finally, the most violated rules identified by the inspector are the simplest with which to comply. I am referring to LAC 46:XXXIII.304 and .703 which require dentists (.304) and hygienists (.703) to provide the board with updated information regarding their mailing addresses and office locations. Without the correct mailing address the board cannot provide you important documents like renewal notices. The majority of license revocations this year occurred because the licensee did not receive a renewal notice. In each instance the failure to receive the notice was caused by the licensee's failure to provide the board with current information. Please remember to update your information with the board to avoid any issues with non-compliance.

The board staff is preparing for our third year of online renewals. The online renewal process has been very successful. Last year renewal certificates and permits were provided to licensees within a week of completing the online process. This year the online renewal process will begin on October 15. The board will be renewing licensees whose names fall in M through Z of the alphabet this year. The board will be mailing renewal information to all licensees by the end of September. In accordance with LSA-R.S. 37:770, the official roster for issuing license renewals or any other official notice shall be the last known mailing address of the dentist, dental hygienist or expanded duty dental assistant as indicated in the board files.

The online renewal process is not complete until all information has been submitted, all questions answered and payment tendered to the board. The board does not send invoices or bills for renewal of licenses and permits. You may complete the online process and pay with a credit card or send in your paper renewal with a check. Next, you may change your mailing and home addresses online but you cannot change your office address. Changes to your office address must be submitted to the board in writing in accordance with LAC 46:XXXIII.304 cited above. The renewal certificate that you receive will include your personal anesthesia permit information on the lower left corner of the certificate. A separate certificate will be produced for any office permit that you may hold. Finally, special attention should be given to the question regarding completion of your continuing education for this renewal cycle.

I look forward to another successful renewal cycle. If I or any member of the board staff may be of assistance to you, please do not hesitate to contact us.

DISCIPLINARY ACTIONS 2011-2012

The following represents summaries of disciplinary actions taken in 2011-2012 by the Louisiana State Board of Dentistry or judgments rendered by the court in connection with civil and/or criminal proceedings and/or appellate proceedings involving registrants of this board. In the event further judicial appeals are taken in any of these matters, they will be reviewed in the next issue of The Bulletin.

KATINA R. BEVERLY, D.D.S.
MONROE, LOUISIANA

Violation - Dr. Beverly was charged with fraud in violation of R.S. 37:776 (A)(16); and submitting false or deceptive claims in violation of R.S. 37:776 (A)(21).

Final Disposition - Dr. Beverly entered into a consent decree with the board wherein she was ordered to pay a fine in the amount of \$55,000 and reimburse the board's costs. Dr. Beverly was placed on probation for 2 years, and she must satisfactorily complete a continuing education course in ethics within 120 days of the date the agreement is ratified by the board.

BILLY F. BOOTY, D.D.S.
BATON ROUGE, LOUISIANA

No Violation

Final Disposition - Dr. Booty entered into an amendment of the original consent decree wherein Dr. Booty's license was reinstated upon his completion of an evaluation and remediation at a board approved institution in all areas of basic dental knowledge and skills at his expense; his satisfactory completion of a continuing education course in ethics; and his satisfactory completion of the dental jurisprudence test. Dr. Booty must practice dentistry only under the direct supervision of other licensed dentists for the first 2 years of his 5 year probation. Dr. Booty must undergo a psychological evaluation by a psychologist or psychiatrist of the board's choosing; submit fingerprints to the board and undergo a background check in accordance with R.S. 37:760; he must fulfill all requirements to reinstate his dental license including but not limited to payment of all fees and costs associated with the reinstatement and renewal of his license. He must complete 20 hours of clinical continuing education within 180 days of the reinstatement of his license.

ROBERT H. CARLSON, D.D.S.
BATON ROUGE, LOUISIANA

Violation - Dr. Carlson was charged with fraud and submitting unnecessary claims in violation of R.S. 37:776 (A)(16) and (21); and failure to obtain a personal anesthesia permit before administering anesthesia to patients in violation of R.S. 37:793 (C)(2) and (3) and LAC 46:XXXIII.1505 and .1506, thereby forming a violation of R.S. 37:776 (A)(24).

Final Disposition - Dr. Carlson entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$10,000 and he was placed on probation for 5 years.

JON D. CELINO, D.D.S.
NEW ORLEANS, LOUISIANA

Violation - Dr. Celino was charged with (1) failure to satisfy the prevailing acceptable standard of care in Louisiana in violation of R.S. 37:776 (A)(8); and (2) the use of deceit in obtaining a dental license renewal in violation of R.S. 37:776 (A)(3).

Final Disposition - Dr. Celino entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$2,000 and reimburse the board's costs.

VINTAGE L. DELAHOUSAYE, D.D.S.
NEW IBERIA, LOUISIANA

No Violation

Final Disposition - Dr. Delahoussaye entered into an amendment of the original consent decree wherein her license was reinstated upon completion of an evaluation and remediation at a board approved institution in all areas of dentistry at

her expense. Upon reinstatement of her license, she was placed on probation for 10 years. Further, she was ordered to undergo monitoring by a board approved monitor during the first 5 years of her 10 years of probation, submit to random drug testing, and successfully complete a 12-step recovery program or other self-help program. She was ordered to reimburse the board's costs.

VINCENT L. DILEO, JR., D.D.S.

METAIRIE, LOUISIANA

Violation - Dr. Dileo was charged with fraud in violation of R.S. 37:776 (A)(16), treatment that was below the prevailing standard of care in violation of R.S. 37:776 (A)(8), and misrepresentations to influence, persuade or induce dental patronage in violation of R.S. 37:776 (A)(12).

Final Disposition - Dr. Dileo entered into a consent decree with the board wherein he was ordered to pay a fine and costs in the amount of \$120,000. Dr. Dileo was placed on probation for a period of 7 years.

GENE DONGIEUX, D.D.S.

METAIRIE, LOUISIANA

No Violation

Final Disposition - Dr. Dongieux's request for reconsideration of adverse sanctions was granted by the board thereby rescinding his prior advertising violation. Dr. Dongieux was ordered to reimburse the board's costs.

CLAY M. DUOS, D.D.S.

EUNICE, LOUISIANA

Violation - Dr. Duos was charged with prescribing, dispensing, or administering habit-forming or other legally controlled substances in other than a legal or legitimate manner in violation of R.S. 37:776 (A)(6).

Final Disposition - Dr. Duos entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$1,000 and reimburse the board's costs; he was placed on probation for 3 years. Dr. Duos must satisfactorily complete continuing education courses in ethics and chemical dependency and opiate management. He must also successfully complete the dental jurisprudence test administered by the board.

NICOLE LYNN GARZA, R.D.H.

GONZALES, LOUISIANA

Violation - Ms. Garza was charged with failure to acquire the requisite continuing education for the renewal of her Louisiana dental hygiene license in violation of LAC 46:XXXIII.1613, thereby forming a violation of R.S. 37:777 (A)(18).

Final Disposition - Ms. Garza entered into a consent decree with the board wherein she was ordered to pay a fine in the amount of \$500 and to obtain the deficient hours of continuing education no later than August 31, 2012.

WENDELL E. GRIMES, D.D.S.

BAKER, LOUISIANA

Violation - Dr. Grimes was charged with failure to acquire the requisite continuing education for the renewal of his Louisiana dental license in violation of LAC 46:XXXIII.1611, thereby forming a violation of R.S. 37:776 (A)(24).

Final Disposition - Dr. Grimes entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$2,000 and obtain the deficient hours of continuing education no later than August 31, 2012.

RALPH D. JACKSON, D.D.S.

ALEXANDRIA, LOUISIANA

Violation - Dr. Jackson was charged with habitual indulgence in the use of drugs, narcotics, and intoxicating liquors in violation of R.S. 37:776(A)(5).

Final Disposition - Dr. Jackson entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$1,000 and reimburse the board's costs; the board will monitor his prescribing habits via the Prescription Monitoring Program yearly for a period of 5 years.

**VELMA J. JACKSON, D.D.S.
BATON ROUGE, LOUISIANA**

Violation - Dr. Jackson was charged with failing to follow proper Federal Center for Disease Control guidelines, thereby forming a violation of R.S. 37:776(A)(24).

Final Disposition - Dr. Jackson entered into a consent decree with the board wherein she was ordered to pay a fine in the amount of \$1,000 and reimburse the board's costs; her license to practice dentistry was suspended for a period of 6 months, the execution of which was deferred and Dr. Jackson was placed on probation for one year. Dr. Jackson must provide the board with the results of her spore testing once per month for 6 months; and she shall satisfactorily complete continuing education courses in sterilization and compliance with CDC guidelines.

**NIOBE A. JOSEPH, D.D.S.
GRETNA, LOUISIANA**

Violation - Dr. Joseph was charged with allowing an unlicensed person to perform work which may only be performed by licensed persons in violation of R.S. 37:776(A)(11) and R.S. 37:775(A)(12).

Final Disposition - Dr. Joseph entered into a consent decree with the board wherein she was ordered to pay a fine in the amount of \$500, and reimburse the board's costs. She was also placed on probation for 6 months.

**KIM MARTIN KENNEDY, R.D.H.
VIOLET, LOUISIANA**

Violation - Ms. Kennedy was charged with failure to acquire the requisite continuing education for the renewal of her Louisiana dental hygiene license in violation of LAC 46:XXXIII.1613, thereby forming a violation of R.S. 37:777 (A)(18).

Final Disposition - Ms. Kennedy entered into a consent decree with the board wherein she was ordered to pay a fine in the amount of \$500 and to obtain the deficient hours of continuing education no later than August 31, 2012.

**MICHELLE N. LEBLANC, D.D.S.
MANDEVILLE, LOUISIANA**

Violation - Dr. LeBlanc was charged with (1) that she committed fraud and performed unnecessary treatment regarding 2 patients in violation of R.S. 37:776 (A)(16) and (21); (2) that she prescribed, dispensed or administered habit-forming or other legally controlled substances in other than a legal or legitimate manner in violation of R.S. 37:776 (A)(6); and (3) that she indulged in the use of drugs, narcotics, and intoxicating liquors in violation of R.S. 37:776 (A)(5).

Final Disposition - Dr. LeBlanc entered into a consent decree with the board wherein she was ordered to pay a fine in the amount of \$10,000 and reimburse the board's costs. Dr. LeBlanc entered into the board's monitoring program; was placed on probation for a period of 5 years; and was required to satisfactorily complete continuing education courses in medical/dental record keeping. Dr. LeBlanc must practice dentistry only under the direct supervision of another licensed dentist for the first 3 years of her probation.

**VIRGINIA LOCKE, D.D.S.
PINEVILLE, LOUISIANA**

Violation - Dr. Locke was charged with habitual indulgence in the use of drugs, narcotics, and intoxicating liquors in violation of R.S. 37:776(A)(5).

Final Disposition -- Dr. Locke entered into a consent decree with the board wherein she was ordered to pay a fine in the amount of \$5,000 and to reimburse the board's costs; she surrendered all state and federal controlled substances prescribing privileges; and she entered into a monitoring program with the board. She was placed on probation for 5 years.

**RHONDA LORRAINE, D.D.S.
CUTOFF, LOUISIANA**

Violation - Dr. Lorraine was charged with administering anesthesia without applicable permits in violation of R.S. 37:793(B) (1) and (2) and LAC 46:XXXIII.1507(A)(1), thereby forming a violation of R.S. 37:776(A)(24).

Final Disposition - Dr. Lorraine entered into a consent decree wherein she was ordered to pay a fine of \$1,000 and reimburse the board's costs. She was placed on probation for 5 years. In addition, she was ordered to successfully complete an adult enteral sedation course.

**GREGG ADAM MAY, D.D.S.
HARVEY, LOUISIANA**

No Violation

Final Disposition - Dr. May entered into an amendment of the original consent decree wherein his license was reinstated upon the completion of an evaluation and remediation at a board approved institution in all areas of dentistry at his expense. Further, Dr. May was ordered to undergo monitoring by an approved board monitor during the first 5 years of his 10 year probation. He was ordered to engage in relapse prevention group therapy; attend a minimum of 3 12-step program meetings per week for a period of 3 years; and submit to random drug testing. He was ordered to pay the board's costs, pay restitution to 3 patients and refrain from conduct for which he surrendered his license.

**RONALD L. MILTON, D.D.S.
LIVINGSTON, LOUISIANA**

Violation - Dr. Milton was charged with failure to satisfy the prevailing acceptable standard of care in violation of R.S. 37:776 (A)(7) and (8); and failure to follow proper Federal Centers for Disease Control guidelines, thereby forming a violation of R.S. 37:776 (A)(24).

Final Disposition - Dr. Milton entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$2,500 and reimburse the board's costs. He must undergo an evaluation and remediation of basic knowledge and skills and infection control. Dr. Milton shall satisfactorily complete a continuing education course in Federal Centers for Disease Control regulations and successfully complete the dental jurisprudence test administered by the board.

**ERNEST E. QUIMBY, D.D.S.
BATON ROUGE, LOUISIANA**

Violation - Dr. Quimby was charged with prescribing legally controlled substances in other than a legal or legitimate manner in violation of R.S. 37:776 (A)(6).

Final Disposition - Dr. Quimby entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$15,000 and reimburse the board's costs. He was placed on probation for 10 years. Dr. Quimby was ordered to immediately surrender his license to prescribe Class II and Class III controlled substances.

**EDGARDO L. RABEL, D.D.S.
BAKER, LOUISIANA**

No Violation

Final Disposition - Dr. Rabel entered into an amendment of the original consent decree wherein the board agreed to reinstate his controlled substances prescribing privileges.

**JAMES MATTHEW RANDALL, D.D.S.
BATON ROUGE, LOUISIANA**

Violation - Dr. Randall was charged with failing to satisfy the prevailing acceptable standard of care in this state in violation of R.S. 37:776 (A)(7) and (8); and allowing an unlicensed person to perform work which may only be performed by licensed persons in violation of R.S. 37:776 (A)(11).

Final Disposition - Dr. Randall entered into a consent decree wherein he was ordered to pay a fine in the amount of \$5,000; reimburse the board's costs; and satisfactorily complete an ethics course. His license was placed on probation for a period of 5 years.

**DAVID REED, D.D.S.
SHREVEPORT, LOUISIANA**

Violation - Dr. Reed was charged with violating R.S. 37:776(A)(24) for violating board rule LAC 46:XXXIII.1203(A) for failure to follow CDC guidelines regarding spore testing.

Final Disposition - Dr. Reed entered into a consent decree wherein he was ordered to pay a fine of \$1,000, and his license was placed on probation for a period of 5 years. He was ordered to provide to the board the results of his spore testing.

NEW IBERIA, LOUISIANA**

Violation - Dr. Babineaux was charged with publishing an advertisement in violation of R.S. 37:775(3) and LAC 46:XXXIII.301, thereby forming a violation of R.S. 37:776(A)(24).

Final Disposition - Dr. Babineaux entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$4,000 and reimburse the board's costs.

**ANTOINE T. BABINEAUX, D.D.S.
NEW IBERIA, LOUISIANA**

Violation - Dr. Babineaux was charged with publishing an advertisement in violation of R.S. 37:775 (3) and LAC 46:XXXIII.301 (G)(3), thereby forming a violation of R.S. 37:776 (A)(24).

Final Disposition - Dr. Babineaux entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$1,000 and provide documentation to the board proving that he has satisfactorily corrected the advertisement.

**JOHN T. BERCIER, D.D.S.
LAKE CHARLES, LOUISIANA**

Violation - Dr. Bercier was charged with publishing an advertisement in violation of R.S. 37:775 (3) and LAC 46:XXXIII.301 (G)(3), thereby forming a violation of R.S. 37:776 (A)(24).

Final Disposition - Dr. Bercier entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$1,000 and provide documentation to the board proving that he has satisfactorily corrected the advertisement.

**WILLIAM A. BOLINGER, D.D.S.
BOSSIER CITY, LOUISIANA**

Violation - Dr. Bolinger was charged with publishing an advertisement in violation LAC 46:XXXIII.301 (G)(3), thereby forming a violation of R.S. 37:776 (A)(24).

Final Disposition - Dr. Bolinger entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$2,000 and provide documentation to the board proving that he has satisfactorily corrected the advertisement.

**ROBERT S. GUIER
SHREVEPORT, LOUISIANA**

Violation - Dr. Guier was charged with publishing an advertisement in violation of LAC 46:XXXIII.301 (G)(1), thereby forming a violation of R.S. 37:776 (A)(24).

Final Disposition - Dr. Guier entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$1,000 and provide documentation to the board proving that he has satisfactorily corrected the advertisement.

**BILLY G. HALL, JR., D.D.S.
BATON ROUGE, LOUISIANA**

Violation - Dr. Hall was charged with publishing an advertisement in violation of R.S. 37:775 (3) and (13), thereby forming a violation of R.S. 37:776 (A)(15); and in violation of LAC 46:XXXIII.301 (G)(2) and (4), thereby forming a violation of R.S. 37:776 (A)(24).

Final Disposition - Dr. Hall entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$2,500 and provide documentation to the board proving that he has satisfactorily corrected the advertisement.

ADVERTISING VIOLATIONS

**RALPH M. HENNESSEE, D.D.S.
LEESVILLE, LOUISIANA**

Violation - Dr. Hennessee was charged with publishing an advertisement in violation of R.S. 37:775 (3) and LAC 46:XXXIII.301 (E)(2) and (G)(2) and (4), thereby forming a violation of R.S. 37:776 (A)(24).

Final Disposition -- Dr. Hennessee entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$5,000 and provide documentation to the board proving that he has satisfactorily corrected the advertisement.

**DANIEL M. PERRY, D.D.S.
LAKE CHARLES, LOUISIANA**

Violation - Dr. Perry was charged with publishing an advertisement in violation of R.S. 37:775 (3) and LAC 46:XXXIII.301 (E)(3) and (G)(3), thereby forming a violation of R.S. 37:776 (A)(24).

Final Disposition - Dr. Perry entered into a consent decree with the board wherein he was ordered to pay a fine in the amount of \$1,000 and provide documentation to the board proving that he has satisfactorily corrected the advertisement.

**GREG PHILLIPS, D.D.S.
LUTCHER, LOUISIANA**

Violation - Dr. Phillips was charged with publishing an advertisement in violation of LAC 46:XXXIII.301, thereby forming a violation of R.S. 37:775(2) and R.S. 37:776(A)(24).

Final Disposition - Dr. Phillips entered into a consent decree with the Louisiana State Board of Dentistry wherein he was ordered to pay a fine in the amount of \$2,500, reimburse the boards cost, and satisfactorily complete the dental jurisprudence test administered by the board within 30 days from the date of this Agreement.

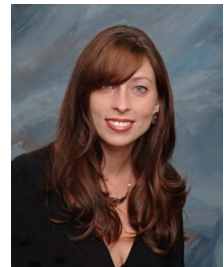

ANESTHESIA PERMIT INFORMATION

DENTIST ANESTHESIA PERMITS

The hierarchy of dental anesthesia permits is as follows:

1. General anesthesia
2. Parenteral deep sedation
3. Parenteral moderate sedation
4. Pediatric enteral moderate sedation
5. Adult enteral moderate sedation
6. Nitrous oxide inhalation

Dentists only hold an anesthesia permit for the highest level of anesthesia they administer, but it allows them to administer any type of anesthesia below it. For example, if you currently hold an anesthesia permit for the administration of level 2 (parenteral deep sedation), then you are qualified to administer levels 2 through 6.

If you are considering taking an anesthesia course at a school other than LSUSD, you should contact the board office prior to completing it to ensure that it will be accepted for your desired level of anesthesia permit.

You may find anesthesia permit applications under “Dental Anesthesia Permit Applications” on the “Forms” page of our website at www.lsbd.org.

HYGIENIST ANESTHESIA PERMITS

IMPORTANT: There is no hierarchy of anesthesia permits for dental hygienists. If you receive a nitrous oxide or local anesthesia permit, you are not automatically authorized to administer the other. You must apply for your nitrous oxide and local anesthesia permits separately.

Nitrous Oxide

Nitrous oxide permits are not automatically given to hygienists after graduation or completion of an approved nitrous oxide course. You must complete the course and fill out the appropriate application and send it along with the payment to the board office to receive your permit. You are not authorized to administer nitrous oxide until you have first received a permit from the board.

Local Anesthesia

Local anesthesia permits are not automatically given to hygienists after graduation or completion of an approved local anesthesia course. You must complete the course and fill out the appropriate application and send it along with the payment to the board office to receive your permit. You are not authorized to administer nitrous oxide until you have first received a permit from the board.

If you are considering taking an anesthesia course at a dental or hygiene school outside Louisiana, you should contact the board office prior to completing it to ensure that it will be accepted for your desired level of anesthesia permit.

What do I need to post in my office?

All Louisiana licensees holding either a dental or a dental hygiene license must display their licenses in full and open view for all patients to observe. You must post both your original license **and** all current renewal certificates of your license and any anesthesia permits.

I opened up a second office. Can I get another original license to display in my new office?

NO. The Louisiana State Board of Dentistry issues only **one** original license (and **one** renewal certificate). You may display copies of any and all licenses and current renewal certificates in the additional offices.

Should your original license be lost or stolen, you must fill out an affidavit of lost license and pay a fee for a new original license to be created. If you simply want an additional original to display in a new office, we will **not** issue it.

When do I have to renew my license?

Licensees whose last names (when they were originally licensed) begin with the letters A through L renew in odd years and will not renew their licenses until December 31, 2013.

Licensees whose last names (when they were originally licensed) begin with the letters M through Z renew in even years and must renew their licenses by December 31, 2012.

I have to renew my license this year. What is the due date?

December 31, 2012. If you renew online, your transaction must be completed by 11:59 PM (Central Time), December 31, 2012. If you renew with the paper form, it must be postmarked no later than December 31, 2012. Any license renewal applications completed after that date will be assessed a delinquent fee.

What happens if I allow my license to lapse or I do not renew it?

If your Louisiana dental or dental hygiene license lapses due to non-renewal, you may not practice dentistry or dental hygiene in Louisiana. Persons who practice with a lapsed license are subject to disciplinary action.

If you are practicing in another state and wish to give up your Louisiana license, please be aware that should you wish to reactivate your license in the future, you will have to re-apply for your license by credentials.

What happens to my license after the expiration date?

Licenses expire December 31, 2012. After that date, you will receive two certified mail notices notifying you of your possible oversight. If we receive no response from you or if you notify the board of your non-renewal intentions, your license will be revoked at the March 2013 board meeting.

ANESTHESIA (DENTISTS)

What is the difference between a personal permit and an office permit?

The personal permit states that the dentist is qualified to administer the indicated level of anesthesia. The office permit states that the premises and equipment where that level of anesthesia is being administered are in compliance with board requirements. You may not administer anesthesia unless you have a personal permit, **and** the location where you are administering the anesthesia has an office permit for that level of anesthesia.

FAQ (continued)

Every dentist in a group practice who intends to administer anesthesia must have his/her own personal anesthesia permit. Only one office permit is required for the office. Dentists may administer any level of anesthesia for which they have a permit in any office where there is a current office permit for that same level.

I'm moving to a new office. Can I use my same office permit at the new location?

NO. Office permits are specifically for the office listed on the permit certificate and **are not transferable**. You must apply for a new office permit at the new location. You may find applications for anesthesia permits on our website.

Adult enteral moderate sedation and nitrous oxide office permits are issued by the board upon approval of your submitted application. Office inspections are not required prior to issuance of the permit. These offices are inspected routinely in the normal course of board business.

Pediatric enteral moderate sedation, parenteral moderate sedation, parenteral deep sedation, and general anesthesia office permits **require an office inspection prior to approval and issuance of the permits**. You must allow adequate time for the processing of these applications.

Do I have to renew my anesthesia permit(s)?

YES. Anesthesia permits expire with the dentist's license and must be renewed.

A personal anesthesia permit is renewed with the dentist's license for an additional fee. If you renew your license online, the total fee listed includes the applicable personal anesthesia permit renewal fee. Your personal anesthesia permit will be listed on the lower left of your dental license renewal certificate.

Office permits currently renew automatically with the dentist's license. There is currently no renewal fee for office permits. These will be mailed to the permit holder along with his/her dental license renewal certificate.

I don't want to pay the personal anesthesia permit renewal fee. How can I give up my permit so that I don't have to pay the renewal fee?

You must notify the board office in writing (postal mail or fax only) that you intend to give up your anesthesia permit. **If you administer anesthesia without a personal permit, you are in violation of the board's rules.**

If you intend to renew your dental license online, you must inform the board office in writing that you are giving up your personal anesthesia permit **prior** to renewing your license online. Once we have received that information and removed your permit information from our database, you may then log in online to renew your dental license.

If you intend to renew your dental license with a paper form, you may indicate on the form that you would like to give up your anesthesia permit(s).

ANESTHESIA (HYGIENISTS)

I have a local anesthesia permit. Do I need an office permit, too?

NO. The board does not issue office permits for the administration of local anesthesia. You may administer local anesthesia in any dental office in Louisiana if you have a permit.

I plan on getting my nitrous oxide permit. Does that mean I may administer local anesthesia, too?

NO. There is no anesthesia hierarchy for hygienists. Nitrous oxide permits and local anesthesia permits are separate permits with different qualifications and applications. You must apply for them separately.

I plan on getting my nitrous oxide permit, but my employing dentist does not use nitrous oxide in his/her dental practice. May I still use nitrous oxide?

NO. You will **not** be allowed to administer nitrous oxide unless you are in an office where the dentist holds a personal nitrous oxide permit **AND** the office has an office nitrous oxide permit.

CE audits will be conducted sometime in the next year for licensees renewing at the end of 2012. Be sure to keep all CE certificates for five years from the date of completion.

Dentists holding enteral moderate sedation or higher level anesthesia permits must take a refresher CE course every 6 years. This course must be pertinent to the level of anesthesia permit held.

FAQ (continued)

I'm working under general supervision. May I administer local anesthesia or nitrous oxide while the dentist is out?

NO. Hygienists may only administer local anesthesia or nitrous oxide under direct supervision.

CONTINUING EDUCATION

My license is up for renewal this year. Do I have to report the CE courses I took over the past two years? Do I have to send my certificates?

Your license renewal notice contained a reporting form on which you must list all CE courses you completed over the past two years. **You do not need to send any CE certificates at this time.** CE audits will be conducted sometime during the first half of 2013 for licensees renewing in December 2012. If you are selected for the CE audit, you will be asked to send in CE certificates at that time.

I just got my license. Do I still have to meet CE requirements?

Dentists and hygienists who were enrolled in dental or hygiene school during the calendar year in which they received their license will not have to complete CE for the year in which they were still enrolled in school. They must still complete CE for the second year of their license term, and all requirements are reduced by one-half.

Dentists and hygienists who received their license but were **not** enrolled in school during the calendar year in which they received their license must comply with **all** CE requirements.

How many continuing education hours do I need to complete? What are the specific requirements?

DENTISTS must have completed 40 hours by the time they renew their licenses. There is a requirement that one-half of the hours be clinical in nature. "Clinical" hours pertain to the actual delivery of dental services directly to the patient. A more specific breakdown is below.

40 total hours

Of those 40 total hours, **20 must be clinical in nature.**

Of those 20 clinical hours, **10 must be personally attended.**

The remaining **10 clinical hours may be personally attended OR online/correspondence courses (still clinical in nature) that require a written test at the completion of the course.**

The remaining 20 hours may be EITHER clinical OR non-clinical.

HYGIENISTS must have completed 24 hours by the time they renew their licenses. There is a requirement that one-half of the hours be clinical in nature. "Clinical" hours pertain to the actual delivery of dental or dental hygiene services directly to the patient. A more specific breakdown is below.

24 total hours

Of those 24 total hours, **12 must be clinical in nature.**

Of those 12 clinical hours, **6 must be personally attended.**

The remaining **6 clinical hours may be personally attended OR online/correspondence courses (still clinical in nature) that require a written test at the completion of the course.**

The remaining 12 hours may be EITHER clinical OR non-clinical.

For more information regarding CE requirements, please refer to Chapter 16 of the Dental Practice Act.

FAQ (continued)

Do I have to complete any CE to maintain my dental anesthesia permit?

DENTISTS who hold an enteral moderate sedation or higher level of anesthesia permit, you must complete a refresher anesthesia course at least once every six years. This course must be pertinent to the level of anesthesia you administer.

Must I send my anesthesia CE certificates to the board?

NO. As with regular CE audits, you will only send anesthesia CE course certificates if you are audited for anesthesia CE. If you are chosen for the audit, you will receive a notice from the board sometime in the first half of the year following your license renewal.

CHANGES OF ADDRESS OR NAME

Can I call the board office and give my change of address or name over the phone? Can I email it?

NO. Changes by telephone or email are **not** accepted. All changes of address or name must be signed by the licensee and in writing. Practice location, employer, and home or mailing address change forms are available on the board website on the "Forms" page. You may fax or mail these changes to the board office.

DENTAL ASSISTANTS AND EXPANDED DUTY DENTAL ASSISTANTS

Does the Louisiana State Board of Dentistry regulate or certify dental assistants?

NO. The board does not regulate dental assistants.

The board provides a certificate confirmation for expanded duty dental assistants only after they have submitted proof of completion of a board approved EDDA course, board approved radiology course, a copy of the acceptable current CPR card, the EDDA certificate confirmation application, and the \$100 application fee. EDDAs may not perform expanded duties in the dental office until they receive their certificate confirmation from the board office.

The EDDA application may be found on the "Forms" page of the board's website at www.lsbdb.org.

I have hired a registered/certified dental assistant. Isn't that the same thing as an EDDA? So can I just allow my new employee to perform the expanded duties?

NO. The Louisiana State Board of Dentistry does not recognize the registered or certified dental assistant as equivalent to the EDDA. Dental assistants may not perform expanded duties in the dental office until they receive a certificate confirmation from the board office after meeting the board requirements.

PRESCRIPTION MONITORING PROGRAM

Are there any reporting requirements for dentists to the PMP?

Reporting to the PMP is required only for dentists **dispensing** controlled substances.

"**Administering**" means the direct application of a drug to the body of a patient by injection, inhalation, ingestion, or any other means.

"**Dispensing**" means the actual preparation and delivery of a controlled substance to the patient. Most dentists write prescriptions and the pharmacy then actually **dispenses** the controlled substance. Therefore, writing a prescription is **NOT** dispensing. Only those dentists who **dispense more than a forty-eight hour supply of controlled substances** to patients prior or subsequent to performing an actual procedure on a patient must report to the PMP.

This does **NOT** affect your ability to prescribe controlled substances. The PMP is for the reporting of **dispensed** controlled substances only. If you are registered as a **dispenser**, you **MUST** report to the PMP no less than once every 7 days, even if those reports are zero controlled substances dispensed.

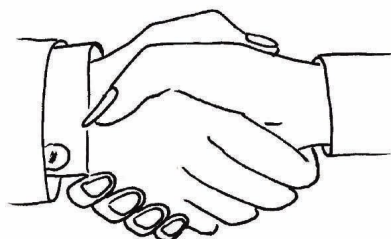
